Subject: Approve Investment Report for Quarter Ended June 30, 2017

RECOMMENDATION:

Staff recommends that the Board of Directors accept and file the attached Investment Report for the quarter ended, June 30, 2017.

BACKGROUND / ANALYSIS:

California Government Code §53646(b) requires the Treasurer or CFO of a local agency to submit a quarterly report on the agency's investments to the legislative body of the agency within 30 days of the end of each quarter.

Discussion

The attached Investment Report shows all of the District's cash and investments, restricted and unrestricted, as of June 30, 2017. Attachment A presents the investment securities purchased and retired during the quarter April to June 2017. Increases and decreases in highly liquid funds, such as LAIF, are explained in the narrative below.

Unrestricted Investments

LAIF

The balance held in the Local Agency Investment Fund at the beginning of the quarter was \$12,094,364. Interest earned during the previous quarter of \$23,139 was posted to the account in April, and as there were no deposits or withdrawals initiated by staff, the balance in the account at the end of the quarter was \$12,117,503.

LAIF earnings for the quarter ended June 30, 2017 were \$27,905, calculated at an apportionment rate of 0.92%; up from 0.78% which had been in effect for the previous quarter. The earnings were posted to the District's account on July 14, 2017.

Citizen's Business Bank (CBB) Wealth Management

The total (book) value of the assets held with CBB increased \$16,464 to \$5,599,566 during the quarter ended June 30, 2017. The balance in this account is held both in a money market account (\$548,207) and in a \$5,051,359 portfolio of Treasury and federal agency securities shown on Attachment A.

Net interest payments received on securities in the District's portfolio were \$19,424 and funds held in money market accounts earned \$273. Earnings were reduced by a \$1,138 amortization charge against discounts taken on the acquisition of certain bonds.
